## INTRODUCTION

The Political Advertisements Collection was donated by Randy Rubel (Acc. #2004.002), Hedy Russo (Acc. #2010.008) the Delta Kappa Gamma Society, Eta Chapter (Acc. #2016.002) and by unknown donors (Acc. #0000.000). The collection contains approximately 88 items arranged into 1 box and 2 loose signs. Access to this collection may be permitted for the purposes of personal and scholarly research. ## SCOPE AND CONTENT NOTE

Over a period of several years, various individuals donated this collection to the Montgomery County Archives. This collection consists of mailers, flyers, stickers, and a sign for various Tennessee elections. Additionally, there are stickers, a pin, and magazines connected to the 2016 U.S. presidential election. The majority of the materials cover local (Montgomery County and Clarksville) elections, primarily between 2014 and 2016. There are two campaign signs from 1966, one for Sam Boaz running for Law and Equity Court Judge and one for Patrick Monaghan running for Floterial Representative of Houston, Humphreys and Montgomery counties. There are also additional newspapers and advertising materials concerning Patrick Monaghan's 1966 run for Floterial Representative.
