#### MONTGOMERY COUNTY BOARD OF HEALTH

Authority: T.C.A 68-2-601 and Resolution 00-01-1 of the Montgomery County Board of Commissioners.

#### Purpose:

- (1) To govern the policies of the full-time county health departments established in accordance with the provisions of T.C.A. 68-2-601, et al.;
- (2) Through the county health director and/or the county health officer, enforce such rules and regulations as may be prescribed by the commissioner essential to the control of preventable diseases and the promotion and maintenance of the general health of the county;
- (3) Adopt rules and regulations as may be necessary or appropriate to protect the general health and safety of the citizens of the county. The regulations shall be at least as stringent as the standards established by a state law or regulation as applicable to the same or similar subject matter. Regulations of a county board of health supersedes less stringent or conflicting local ordinances; and
- (4) To approve and submit an annual budget to the county legislative body for consideration and subsequent provision of necessary funds to meet all obligations under the adopted budgets.

## Membership: Nine (9) members.

- (1) The County Mayor;
- (2) The director of schools, or designee appointed annually by such director;
- (3) Two (2) physicians licensed to practice in the state of Tennessee, who shall be nominated by the Montgomery County Medical Society.
- (4) One (1) dentist licensed to practice dentistry in the state of Tennessee, who shall be nominated by the Montgomery County Dental Society.
- (5) One (1) pharmacist licensed to practice in the state of Tennessee, who shall be nominated by the Montgomery County Pharmaceutical Society.
- (6) One (1) registered nurse licensed to practice in the state of Tennessee, who shall be nominated by the Montgomery County Nursing Association.
- (7) One (1) doctor of veterinary medicine, who shall be nominated by the Nominating Committee.
- (8) One (1) citizen representative, nominated by the Nominating Committee, who shall not, at the time of such citizen representative's election, previous to such citizen representative's election, nor during the term of such citizens representative's office, be a health provider or the spouse of a health provider.

The county health director and the county health officer shall serve as ex officio members to the board, with the county health director serving as secretary to the board. All members, except ex officio members shall be residents of the county. Nominations shall be submitted to the Nominating Committee and approved by the Board of Commissioners.

<u>Terms:</u> The terms of the County Mayor, director of schools and county health director

shall be coterminous with their terms or duration of office.

The terms of all other members shall be for four (4) years to be elected in

October, not to exceed two (2) consecutive full four-year terms.

Meetings: Annually to approve the budget, or when necessary as determined by the Board

Chairman, County Health Director, or a majority of the membership of the Board.
