## CLARKSVILLE-MONTGOMERY COUNTY COMMUNITY ACTION AGENCY

<u>Authority:</u> Provisions of the Tennessee General Corporation Act (non-profit), Section 210 of the Economic Opportunity Act of 1964, Montgomery County Board of Commissioners Resolution, dated November 13, 1978, and by this Resolution; and Resolution 19-1-11

**Purpose:** To provide an organization exclusively for charitable, religious, and scientific purposes, including, for such purposes the making of distributions to organizations under Section 501 (c)(3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law) as set forth on Page 2 of the STATE OF TENNESSEE CHARTER, May 20, 1981.

Membership: In compliance with the by-laws of the Agency, Article III, membership shall consist of twelve (12) members, one-third of whom shall be allotted to public officials, one-third to private sector and one-third to poor sector. In compliance with the resolution of the Montgomery County Board of Commissioners, referred to herein, the public officials' membership of the Board shall consist of the Montgomery County Mayor, one member of the Montgomery County Board of Commissioners, the Mayor of the City of Clarksville, and one member of the Clarksville City Council, or their respective designated representatives.

**Terms:** Four (4) years for members of the private and poor sectors. Appointees of public elected officials serve at the pleasure of the designating officials.

<u>Meetings:</u> Third Thursday of September, November, January, March, May, and July of each year.

**Compensation:** As specified in Section I (applies to County Commissioner only)
