ECONOMIC and COMMUNITY DEVELOPMENT BOARD

Authority: T.C.A. 6-58-114 and 6-58-114(f). There shall be established in each county a joint Economic and Community Development Board that shall be established by inter-local agreement pursuant to T.C.A. § 5-1-113, and Resolution 19-1-11

Purpose: It was the intent of the General Assembly that local governments engage in long-term planning efforts and, that such efforts be accomplished through regular communication and cooperation among local governments. The purpose of the Board is to foster communication relative to economic and community development between and among governmental entities, industry, and private citizens.

Membership: The Board shall be composed of representatives of county and city governments, private citizens, and present industry and businesses. The final makeup of the Board shall be determined by inter-local agreement but shall at a minimum include the County Mayor and the City Mayor and one person who owns land qualifying for classification and valuation under T.C.A., Title 67, Chapter 5, Part 10.

There shall be an executive committee of the Board, which must as a minimum include the County Mayor and the City Mayor. The membership of the executive committee is to be determined by the entire Board's membership.

Terms: The terms of office shall be determined by the inter-local agreement but shall be staggered except for the positions held by elected officials whose terms shall coincide with the terms of office for their elected positions. All terms of office shall be for a maximum of four (4) years.

Meetings: The full Board shall meet, at a minimum, four (4) times annually and the executive committee of the full Board shall meet at least four (4) times annually. All meetings are subject to the open meeting laws of the State of Tennessee with minutes to be kept to record all the proceedings.

Funding: The funding for the Board shall be a joint responsibility of the participating governmental units based upon the percentage of their population of the overall County. Population levels to be determined by the last Federal decennial Census count.

Compensation to Board Members: None. Reimbursement for travel to out of town meetings, seminars or educational forums at actual expenses incurred or agreed upon per diem is allowed. Use of private vehicles shall be reimbursed at the currently adopted County rate schedule as per standing County travel policy. As specified in Section I (applies to Commissioner only)
