ECONOMIC DEVELOPMENT COUNCIL

Authority: Resolution Number 95-1-3 of the Montgomery County Board of Commissioners dated January 9, 1995; by-laws of the Economic Development Council and Resolution 19-1-11

Purpose: A non-profit economic development umbrella agency that provides management and a unified direction for the Clarksville Area Chamber of Commerce, the Clarksville-Montgomery County Industrial Development Board, the Tourist Commission and the Downtown District Partnership; to develop, coordinate and implement a comprehensive marketing plan relating to economic development in Montgomery County and to further and advance the general welfare and economic prosperity of Clarksville-Montgomery County and the surrounding trade area.

Membership: Nineteen (19) voting members and five (5) ex officio non-voting members. Two (2) of the nineteen voting members shall consist of the County Mayor and one member of the Board of Commissioners appointed by the County Mayor.

Terms: The term of the County Mayor shall be coterminous with the term of office. The term of the County Commissioner shall be for two (2) years, not to exceed one (1) full two-year term, unless such commissioner is fulfilling an unexpired term.

Meetings: Quarterly

Compensation: None, except for the member serving as County Commissioner as specified in Section I.
