**CLARKSVILLE-MONTGOMERY COUNTY HISTORICAL MUSEUM
BOARD OF TRUSTEES**

Authority: Charter, State of Tennessee, dated January 6, 1983, and Resolution by the Montgomery County Board of Commissioners dated October 11, 1982 and Resolution 19-1-11.

Purpose: To be responsible for establishing policy and administering all the affairs and operations of the Clarksville-Montgomery County Historical Museum and the furthering of the understanding of the historical development of Clarksville and Montgomery County from the beginning to the present.

Membership: Thirteen (13) members, seven (7) of whom shall be nominated by the City Mayor with approval of the City Council, and six (6) of whom shall be nominated by the Nominating Committee with approval by the Board of County Commissioners.

Nominations of new members shall be submitted by the chairman of the Historical Museum Board of Trustees to the City Mayor or to the Montgomery County Nominating Committee in September and shall assume office as of October 1. The City Mayor shall annually appoint one (1) City Council member to serve as an ex officio member of the Board and the County Mayor shall annually appoint one (1) County Commissioner to serve as an ex officio member of the Board. The County Historian and the president of the Clarksville Area Chamber of Commerce shall also serve as ex officio members of the Board. The ex officio members shall serve in addition to the thirteen (13) regularly appointed Board members; however, no ex officio member shall be eligible to vote or hold an office on the Board.

Terms: The term of office for regularly appointed Board members shall be three (3) years. Provided, however, that of the initially appointed members six (6) shall serve terms of two (2) years and seven (7) shall serve terms of three (3) years, the term of each to be designated at the time of appointment. All subsequent regular appointments shall be for terms of three (3) years, it being the intent that members shall serve three (3) year terms on a staggered basis. No member may serve on the Board for more than six (6) years in succession. After a one-year absence from the Board, any former member may be reappointed. The appointment of the ex officio members by the City Mayor and the County Mayor shall be annually.

Meetings: The Board shall hold regular monthly meetings. Special meetings may be called by the chairman.

Compensation: None; except for the Commissioner serving on the Board.
