REGIONAL PLANNING COMMISSION

Authority: TCA 13-3-301 et seq., 13-1-106, 13-3-401 et seq., 13-7-101, Board of Commissioners Resolution dated May 13, 2002, City Council Ordinance dated March 26, 2002.

Purpose: To make and adopt a general regional plan for the physical development of the territory of the region, with the general purpose of guiding and accomplishing a coordinated, adjusted, efficient and economic development of the region which will, in accordance with present and future needs and resources, best promote the health, safety, morals, order, convenience, prosperity and welfare of the inhabitants, as well as efficiency and economy in the process of development. Such plans, or parts thereof, as adopted by the Regional Planning Commission, may be ratified or overruled by the Board of County Commissioners or City Council.

Membership: Nine (9) persons designated by the Director of the State Planning Office from nominations made in writing by the County Mayor and City Mayor. Not more than four members may come from the county or city governments. A majority of the members must hold no salaried public office (except faculty members of a university or other educational institutions). The City Mayor nominates three of the non-governmental members and the County Mayor nominates two. The City Mayor nominates the two city governmental members and the County Mayor nominates the two county governmental members. Appointments are made in January.

Terms: Four (4) years, on a staggered basis for the non-governmental members. Terms of governmental members are coterminous with their terms of office. Members nominated by the County Mayor and City Mayor shall serve for not more than three (3) full four-year terms in succession.

Meetings: Monthly, and at the call of the chairman of the Regional Planning Commission, or a majority of the members of such commission.

Compensation: As specified in Section I.
