



ADVERTISEMENT FOR BIDS (BID # 2026-0704)

Sealed bids for the **Veterans Plaza Gutter Replacement** located at 350 Pageant Lane, Clarksville, TN 37040 will be received by Elizabeth L. Black, Purchasing Agent, Montgomery County Purchasing at 350 Pageant Lane, Suite 101-E, Clarksville, TN 37040 until **2:00 P.M. on Tuesday, August 25, 2026. At which time the bids will be publicly opened.**

The Scope of Work for this project includes:

This **BASE BID** consists of all work associated with the removal of the existing gutters and downspouts on the south and part of the west side of the building and installation of new gutters and downspouts. Any damage done to existing conditions will need to be repaired and/or replaced to current conditions.

This does not encompass the entire scope of work to be done so the contractor will need to review the documents and make certain that all portions of the project are included in their bid.

In order to bid, qualified bidders shall obtain one (1) copy of the bid document files in PDF format prior to or immediately following the mandatory Pre-Bid Conference. Contractors, sub-contractors, and suppliers may obtain a link to the PDF contract documents by requesting them via email from Montgomery County Engineering engineer@montgomerytn.gov. Upon request, an e-mail response will be sent back within 48 hours with a link to download the project documents.

All Bidders must be licensed Contractors in the State of Tennessee in strict accordance with State regulations. No bid will be opened unless the outside of the sealed envelope containing the bid provides the following information: the Contractor's name, address, and license number; the date of the license expiration; and a quotation of that part of the license classification applicable to the bid.

Each Bidder must deposit (with his/her bid) bid security in the amount of five percent (5%) of the amount of the bid and subject to the conditions provided in the Information for Bidders.

No Bidder may withdraw his bid for sixty (60) days following the bid opening.

The right to reject any or all bids and to wave technicalities is reserved by the owner.
